WHO WE ARE



MISSION

We are a 501(c)(3) nonprofit organization dedicated to saving lives through water safety education, legislation, and increasing equitable access to swim lessons and tools.

VISION

We are working to completely shift society's collective thinking surrounding swimming and water safety. We're pushing swimming first and foremost as an absolutely necessary, life-saving skill, instead of simply a sport and recreational activity. We are building an aquatic community where everyone feels welcome and safe.

VALUES

Inclusivity: We strive to cultivate an inclusive environment both within our organization and through our work in communities.

Promoting Equity: The statistics surrounding aquatic accidents are steeped in discrimination, systemic racism and financial exclusion. In an effort to rectify wrongs, past and present, we prioritize the families and children most in need of our services to directly address the disparities.

Creative Accommodation: We strive to recognize and understand the unique needs of different communities and families. Solutions to advancing aquatic safety are not one-size-fits-all. Therefore, No More Under is pushing boundaries and exploring creative ideas to accommodate the communities we serve.

Collaboration: Building and nurturing relationships with water safety advocates, healthcare professionals, community organizations, businesses and political figures is vital to the progress and success of the water safety and drowning prevention movement we're building.



YORI'S STORY



In August 2018, No More Under's Founder and Executive Director, Chezik Tsunoda, lost the third of her four boys, Yori, to a drowning accident. It occurred at a small gathering in a backyard pool and happened within minutes. Yori was only 3 years old.

Stories like this are quite common, yet we rarely hear about them on the news or in discussions. We all know the importance of placing children in car seats, childproofing the electrical outlets, fencing off access to stairs, and even monitoring screen time. Drowning, however, is the number one cause of accidental death for children aged 1-4, and the second cause of death for children aged 1-14. It's a fact that drowning is a silent killer, and we don't talk about this enough.

Yori's tragedy and the lack of water safety awareness, in communities across the US, were Chezik's motivations for creating No More Under. Her goal is to do everything she can to ensure other families don't endure similar tragedies. His legacy lives on through No More Under's mission and work.



DROWNING STATISTICS

Our nation loses **11** school buses of children to drowning **every year**. In the United States, nearly **1,000 youth** die from unintentional drowning.



For every child under age 18 who dies from drowning, another 7 receive emergency department care for nonfatal drowning.

- 79% of children in households earning less than \$50,000 have little to no swimming ability.
- 76% of parents have reported that their children would be more likely to swim if they saw a talented swimmer that looked like them.
- Children who qualify for free or reduced school lunch programs are 63% less likely to have swimming skills.
- Drowning fatalities happen 5.5 times more frequently for Black children than white children in the same age group. ³

Some families remain unaware of the dangers associated with pools and open water, while others face financial constraints or logistical challenges in getting their children to lessons. Addressing these barriers head-on, we've forged impactful partnerships with organizations that share our commitment to reducing drownings and promoting equity in aquatics.

While we acknowledge that swimming alone is not foolproof in preventing drowning incidents, we understand the significance of instilling the importance of layers of safety and bringing awareness to every parent and child. Our program goes beyond teaching swimming skills; we educate children and parents on crucial aspects like the use of life jackets, the role of a water watcher, and seeking permission before entering the water. These seemingly small actions have a profound impact on how our participants behave around and understand water. It empowers them with the knowledge that many of us don't know ourselves or take for granted.

In addition to our local initiatives, the global impact of the film *Drowning in Silence* continues to unfold. I have spoken to people around the world who have felt the film's impact. It's moments like these that reaffirm the ripple effect of our collective efforts, creating a positive change that goes beyond what we can immediately see.

I want to emphasize that your support is at the core of our endeavors. While we are the ones on the ground working towards our mission, it is your generosity that makes it all possible. Enclosed in this report is a comprehensive overview of our achievements in the past year and a glimpse into our plans for 2024. OUR YEAR IN A SNAPSHOT



As we've grown, we've challenged ourselves to define our areas of focus. There are many ways to support water safety and drowning prevention. We have determined that our approach will be centered around Swim Lessons, Advocacy and Education, and Community Engagement. This year we have focused our efforts on these three pillars and will continue to do so to ensure that we are optimizing our impact with the resources available to us.

SWIM LESSONS

From 2022 to 2023 we more than tripled our impact! We supported **over 700 children** through free swim lessons which equated to **4,121 lessons**. We also supported our first two programs out-side of Washington state, entering into Colorado.



ADVOCACY AND EDUCATION

Washington state Representative April Berg helped us to **successfully craft and pass House Bill 1750, also known as Yori's Law**. The law promotes national water safety goals and officially designates May 15th as Water Safety Day in Washington.

COMMUNITY ENGAGEMENT

We participated in more than 15 community events in 2023. We hosted and supported fundraisers and participated in many Community Engagement fairs from the City of Seattle down to Tacoma. This year had lots of planning with the intention to encourage and support our local communities to engage with aquatics.



OUR YEAR IN A SNAPSHOT



LIFE JACKETS

Our life jacket loaner stations are currently being installed at five Bellevue beaches. Lifejackets are an important layer within water safety and we are grateful that we were able to partner with the **City of Bellevue, Hermanson Company, and Mukilteo Powder Coating** to get them completed. In addition to our stations, we've been working with the Washington State Parks Department to provide free life jackets at events.



CONFERENCES

Chezik was a presenter at the **World Drowning Prevention Conference** in Perth, Australia and also spoke on two panels about our work and being a parent advocate. Tash presented at the **Safe States Conference** in Denver, which also recognized Chezik with an award for our work in Health Equity. We attended the **Association of Aquatic Professionals and National Drowning Prevention Conference** in Colorado as well as the **Safe Kids Injury PrevCon** in Maryland. Chezik spoke on a panel at PrevCon regarding Diversity, Equity, and Inclusion within aquatics. During this trip she was able to spend a day on Capitol Hill to advocate for more water safety measures with Washington state legislators.



EXPANSION OF THE TEAM

This year we gained three additional team members including our **Community Engagement Coordinator, Aquatic Experience Director, and Program Assistant**. The expansion of our team is critical and reflects our intention to sustain our impact for years to come.



SWIM LESSONS



Our swimming lesson programs are one of our three core pillars which will help save lives. While swim lessons cannot entirely prevent drowning, being competent and having skills in the water does reduce the chance of drowning.



Our programs work to remove three existing barriers in aquatics:

Financial Barriers: Swim lessons are expensive! Most group lessons are over \$150. We provide free lessons, gas vouchers, caps, and goggles to help address the financial barrier.

Cultural Barriers: Due in large part to our nation's legacy, racial discrimination and segregation, Black and brown families were legally, and often violently, excluded from aquatic spaces. Since children have only a 13% likelihood of learning to swim if their parents cannot, the residual impact of non-white families being excluded from pools and beaches are reflected in today's drowning statistics. Through targeted outreach and intentional partnerships, dismantling cultural barriers to water safety and drowning prevention is at the core of our work.

Informational Barriers: The deeper we dig into aquatics, the more we've learned that families do not understand the importance of water safety and ways to swim safely. We've also learned that there are various support systems available to help families access aquatics, however, much of the information and opportunities are not reaching our community members who need the most support.

REFLECTION AND PRIORITIES

Our rapid growth this year required us to develop more efficient and sustainable processes to ensure impact for years to come. It also required us to reflect on our programming and consider how it will evolve moving forward.

We've determined that our strength is in supporting condensed aquatic programs with families in our community who are traditionally excluded from aquatics. The majority of these condensed programs partner with existing aquatic facilities and swim schools, and invite families from our local community organizations for a five or eight day introduction to aquatics and water safety.

These introductory programs help families enter into aquatic spaces, and encourage finding the joys of swimming. We also share water safety knowledge with our swimmers and their family members, which can literally save lives. However, introductory programs often do not leave children with proficient swimming abilities and swimming is a skill that needs continued practice. Stepping into 2024, we will ensure that every condensed program offers our participating families an opportunity to enroll in additional lessons at a subsidized rate, ensuring this pathway maintains family engagement in aquatics and encourages safer swimmers.



SWIM SAFELY SERIES

In 2024, we are launching an additional introductory aquatic program, the Swim Safely Series. This series is a water safety clinic led by collegiate swimmers for children in their communities to increase access to aquatics.

We developed a unique curriculum centered around water safety and self rescue. We will provide volunteer collegiate swimmers training to equip them to teach aquatic skills to their community over a five day period.

In 2023, we piloted this program with two collegiate swim and dive teams: **The University of Denver and Colorado State University-Pueblo.** The pilots were a huge success.

In 2023, we had the distinct honor of working with Representative April Berg, from Washington's 44th district, to craft and help pass first-of-its-kind water safety legislation in Washington state, HB 1750, also known as Yori's Law. In addition to promoting national water safety goals in our cities and counties, the law designates May 15th as the official Water Safety Day in our state.



We believe that providing dry land water safety education to children in our state's public schools will be the best way to optimize our water safety education and drowning awareness reach. Water safety begins outside of the water.

We're grateful to be a part of, and to be actively growing, a strong water safety coalition that includes, but is not limited to, educators, water safety advocates across various sectors, medical professionals, swim instructors, and community members who've experienced various water-related trauma. They will be indispensable in helping us shape both our water safety education curriculum and our future advocacy efforts.



CHALLENGES

The greatest challenge to successfully advocating for drowning prevention measures is persuading lawmakers and community members of the urgency surrounding this issue.

GOALS FOR FUTURE

Over the next couple of years, No More Under is looking forward to making an impact in our Washington state educational system. We want to provide essential drowning prevention education to K-12 students. We currently are working with our local legislators to propose statewide education policy that would make water safety education mandatory in public schools.

We are also working to streamline and promote data collection surrounding drowning, nationwide. Currently, the best available drowning data is incomplete, outdated and often contradictory. Optimizing data collection will strengthen and better inform water safety efforts across the country.

Community is No More Under’s third and final pillar. Community encompasses our participation at events, developing relationships with similar organizations, our work with volunteers, and the development of our ambassador programs to offer engagement and careers in aquatics.

Over the summer we hosted **five fundraising events** raising over **\$16,000**. Swim-a-thons were one of the ways we connected with country clubs and actively engaged their community in our mission. These donations are so important because they help support our programs.

In addition to fundraising events, we joined many community events including the **Bellevue School District Health and Wellness Fair, the City of Seattle Big Day of Play, the Tacoma Police Department Health and Safety Fair, Holgate Church**, and so many more. We supported over **15 events** in 2023 by spreading water safety information, Water Watcher badges, stickers, coloring books and information to make sure our community had access to the opportunities we have available.



CHALLENGES

Time is extremely valuable and we've found that it's easier to encourage financial donations rather than time. Finding volunteers to support our presence at events throughout King County has been challenging which is one of the reasons why we're expanding our Teen Ambassador Program. This program is to encourage more engagement from high school students who are required to achieve volunteer hours.

They were extremely influential in our community fundraising efforts. GOALS FOR THE FUTURE

In 2024 we will continue increasing our community engagement which will be supported by our intention to expand our volunteer program. We will continue expanding connections with country clubs to support funding for our swim lesson programs. With the expansion of our Teen Ambassador Program, we will provide pathways for being a lifeguard, swim instructor, and other creative opportunities for teenagers to engage with aquatics.

During the past year, our social media efforts made significant waves, reaching and resonating with our incredible community.


Our messages and mission reached nearly half a million people (477,895) across Instagram, Facebook, and LinkedIn accounts, amplifying our mission to promote water safety education and equitable access to swimming tools.

We're thrilled to report over 11,000 engagements, which showcases the active involvement and support of our dedicated community. From likes to shares, each interaction helped propel our cause forward.



Also, a warm welcome to the nearly 1,500 new members who joined our online community! Some as far as England, Australia, and Canada. With over 8,600 likes (23% increase from 2022) and nearly 100,000 impressions on Instagram, the platform remains our best performing social channel allowing us to reach and engage with our community.

In 2024, we are strategically introducing our TikTok channel as part of our initiative to broaden our reach and establish connections with both our existing and prospective community members.



DROWNING IN SILENCE



Drowning In Silence is a documentary film directed by Chezik, chronicling her quest for answers after Yori drowned. Chezik met with and shared the stories of families who'd also been impacted by the devastating effects of childhood drowning. It is a raw depiction of loss, perseverance, and community which shows how pain can be turned into purpose and truly effect change.

The film was released in May of last year and is currently on various platforms including **Apple TV, Amazon, Dish, Direct TV**, and multiple other retailers. In addition to online streaming, we partnered with various organizations to hold private screenings. Some of these events included a Q&A with Chezik, while others used the film to raise awareness in their communities.

One of our most powerful screenings was in Washington D.C. last spring. **Congresswoman Debbie Wasserman-Schultz (FL) and the Consumer Product Safety Report Chairman, Alex Saric**, joined Chezik for a panel discussion about the state of water safety. Our partners at **Safe Kids and Miss Tristan** sponsored the event, while **Picture Motion** supported the logistics and invitations to partners and legislators in Washington D.C.

This is a powerful film that has reached parents, peditricians, politicians and advocates on several continents. Chezik is hopeful that this project will continue to be used as a source of healing for those who need it as well as a resource to others.

NOELLE, AQUATIC ENGAGEMENT




